# **ISSUES**

- 1. How many members does <u>LLC</u> have for federal tax purposes?
- 2. Does the fact that <u>Son</u> originally indicated that <u>Father</u> was a member affect the determination of whether <u>LLC</u> is a single- or multi-member entity?
- 3. How is it determined how many members an LLC has for federal tax purposes?
- 4. If <u>Son</u> reported the income and expenses from the business on his Schedules C, and represents that he is the only member, should this be enough to consider the <u>LLC</u> a single member LLC and treat it as such back to <u>Year 1</u>?
- 5. If no income/loss from the business had been reported on any type of tax return, would this make a difference in this particular case? In the alternative, if one member reports all the income from the business, does this preclude anyone else from being a member of the LLC?
- 6. As active involvement by all the members of an LLC is not a requirement for the LLC to be treated as a multi-member LLC, and as there is no formal form filed either with the state or federal government that indicates who the members of the LLC are, how does the Service determine if there are actually multiple members other than relying on the interviewed taxpayer's word?

#### CONCLUSIONS

- 1. Under the facts presented, it is unclear whether <u>LLC</u> has one or more members for federal tax purposes.
- 2. <u>Son</u>'s representations as to the ownership of <u>LLC</u> are taken into account in determining whether the entity has one or more than one member.
- 3. For purposes of classification, each owner of an eligible entity that is recognized as a separate entity is counted in determining whether an eligible entity is a single- or multi-member entity.
- 4. In the absence of evidence to the contrary, credible evidence that one member reported all of the income and expenses of an entity and purports to be the only

member is clearly sufficient to establish those facts. The facts of this case provide conflicting evidence of ownership, however.

- 5. Failure to report income/loss does not resolve the question of ownership of the entity or the classification of a business entity under §§ 301.7701-1 through -3 of the Procedure and Administration regulations.
- 6. Section 6031 provides that a partnership must furnish the names and addresses of its partners on its annual return of partnership income.

# **FACTS**

Records at the Office of the Secretary of State for <u>State</u> indicate that <u>LLC</u> was created on <u>Date 1</u> by <u>Son</u> and <u>Co-Organizer</u>. At some point in time prior to the Internal Revenue Service's (Service's) awareness of and/or involvement with <u>LLC</u>, <u>Co-Organizer</u> severed ties with <u>LLC</u> and <u>Son</u> assumed full control of <u>LLC</u>. <u>LLC</u> does not appear to have articles of organization or ownership documents.

In <u>Year 1</u> the Service first became aware of <u>LLC</u> when <u>LLC</u> requested a taxpayer identification number (TIN) and indicated that it was a partnership with <u>Son</u> as a general partner. Further, <u>LLC</u> has not filed a Form 8832, Entity Classification Election, electing to be treated as other than its default classification.

With regard to employment tax liabilities, <u>LLC</u> refused to cooperate with the Service. As a result, the Service initiated procedures under  $\S$  6020(b) of the Internal Revenue Code and assessed the employment taxes. Subsequently, <u>Son</u> represented that <u>Father</u> became a member of <u>LLC</u> at approximately the time the TIN was requested and that  $\underline{x}$  percent of <u>LLC</u> was owned by <u>Son</u> and  $\underline{y}$  percent by <u>Father</u>. Based upon the information supplied when requesting a TIN and on these representations, upon failure to pay the assessed taxes, a notice of federal tax lien (NFTL) was filed in the name of <u>LLC</u>.

Subsequent to the filing of the NFTL, <u>LLC</u>'s authorized representative contacted the Service and stated that <u>LLC</u> should be treated as a single member LLC and not as a multi-member LLC. The representative explained that <u>Father</u> was not a member, rather that <u>Father</u> was only an investor. Further, the representative explained that <u>Son</u> reported all of the income from <u>LLC</u> on his Form 1040, U.S. Individual Income Tax Return, (Schedule C, Profit or Loss From Business) for each year of <u>LLC</u>'s existence.

When the revenue officer interviewed <u>Father</u>, <u>Father</u> confirmed that he invested money into <u>LLC</u>, but that was the extent of his involvement. <u>Father</u> also explained that he had no knowledge of being a member of <u>LLC</u> and that he understood <u>Son</u> to be the sole owner of LLC.

#### LAW AND ANALYSIS

<u>Issue 1</u>: How many members does <u>LLC</u> have for federal tax purposes?

Section 301.7701-2(a) of the Procedure and Administration Regulations provides that a business entity with two or more members is classified for federal tax purposes as either a corporation or a partnership, and a business entity with only one owner is classified as a corporation or is disregarded; if the entity is disregarded, its activities are treated in the same manner as a sole proprietorship, branch, or division of the owner. Section 301.7701-3(a) provides that a business entity that is not classified as a corporation under § 301.7701-2(b)(1), (3), (4), (5), (6), (7), or (8) (an eligible entity) can elect its classification for federal tax purposes. Section 301.7701-3(b)(1) provides that, unless it elects otherwise, a domestic eligible entity with two or more members is a partnership and is disregarded as an entity separate from its owner if it has a single owner.

Thus, in order to determine the federal tax classification of <u>LLC</u> it is necessary to determine how many separate entities (including individuals) are owners of <u>LLC</u>. <u>Cf.</u> Rev. Rul. 2004-77, 2004 I.R.B. 119 (despite having two members under local law, an entity has a single owner for federal tax purposes if one of the members is a disregarded entity owned by the other member).

There is insufficient evidence to determine the number of owners of <u>LLC</u>. There are apparently no ownership documents or articles of organization. Moreover, inconsistent information has been provided. <u>Son</u> has asserted that <u>Father</u> is an investor and an owner of <u>y</u> percent of <u>LLC</u>. In contrast, <u>Father</u> and <u>LLC</u>'s authorized representative have asserted that <u>Son</u> is the single owner of <u>LLC</u>.

<u>Issue 2</u>: Does the fact that <u>Son</u> originally indicated that <u>Father</u> was a member affect the determination of whether <u>LLC</u> is a single- or multi-member entity?

A taxpayer's intent (or lack thereof) to form a partnership as expressed in reporting of income and representing the status of an LLC to the Service is relevant to the question of whether there is a partnership. <u>See Commissioner v. Culbertson</u>, 337 U.S. 733, 742-743 (1949). Given the conflicting evidence of intent here, however, <u>Son</u>'s representations alone are not determinative of the entity's status as a disregarded entity or a partnership.

<u>Issue 3</u>: How is it determined how many members an LLC has for federal tax purposes?

Whether an LLC is a single or multi-member LLC depends on how many separate entities (including individuals) that are recognized for federal tax purposes are owners (again for federal tax purposes) of the entity. Ownership generally involves an analysis of who has the benefits and burdens and control of the entity. See, e.g., <u>Grodt & McKay Realty</u>, Inc. v. Commissioner, 77 T.C. 1221, 1237-1238 (1981).

Thus, the determination as to whether there is more than one owner of an LLC is dependent on the facts and circumstances of each case.

<u>Issue 4</u>: If <u>Son</u> reported the income and expenses from the business on his Schedules C, and represents that he is the only member, should this be enough to consider the <u>LLC</u> a single member LLC and treat it as such back to <u>Year 1</u>?

Credible evidence that one member of an LLC reported all of the income and expenses from the LLC's business for each year of its existence and represents that he or she is now and has always been the sole owner of <u>LLC</u> would be sufficient to consider <u>LLC</u> a single member entity unless or until there is credible evidence to the contrary. Under the facts here, there is conflicting evidence as to whether <u>LLC</u> has a single or multiple members.

<u>Issue 5</u>: If no income/loss from the business had been reported on any type of tax return, would this make a difference in this particular case? In the alternative, if one member reports all the income from the business, does this preclude anyone else from being a member of the LLC?

See discussion under Issue 1. Failure to report income/loss does not resolve the question of ownership of the entity or the classification of a business entity under §§ 301.7701-1 through -3 of the Procedure and Administration regulations.

<u>Issue 6</u>: As active involvement by all the members of an LLC is not a requirement for the LLC to be treated as a multi-member LLC, and as there is no formal form filed either with the state or federal government that indicates who the members of the LLC are, how does the Service determine if there are actually multiple members other than relying on the interviewed taxpayer's word?

A partnership has an obligation under § 6031 to file a return for each taxable year that includes the names and addresses of the individuals who would be entitled to share in the taxable income if distributed. See also discussion under Issue 3 above.
