General Instructions

Section references are to the Internal Revenue Code.

An Item To Note

For purposes of determining a fund's required distribution for a calendar year, a fund that holds a partnership interest must take into account the fund's share of partnership items of income, gain, loss, and deductions as they are taken into account by the partnership, regardless of the tax year of the fund or the tax year of the partnership in which the fund is a partner. See Rev. Rul. 94-40, 1994-1 C.B. 274, and the instructions for lines 1a and 2a. Also see Rev. Proc. 94-71, 1994-49 I.R.B. 11, for the circumstances under which the IRS will not challenge consistent use of a method for partnership items even though the method does not comply with Rev. Rul. 94-40.

Purpose of Form

Form 8613 is used by regulated investment companies (RICs) to figure and pay the excise tax on undistributed income under section 4982. The tax is 4% of the excess, if any, of the required distribution over the distributed amount. The form is also used to make the election under section 4982(e)(4).

Who Must File

Any RIC that is liable for the tax on undistributed income or that makes an election under section 4982(e)(4) must file Form 8613. A RIC that makes this election must file the form even if no tax is due.

If a RIC has more than one fund, each fund files a separate Form 8613. The term "fund" refers here to the definition in section 851(h) and to any RIC that does not have more than one portfolio of assets.

Exemption.—The tax does not apply to funds in which all the shareholders during the year were certain trusts or segregated asset accounts of a life insurance company. Shares attributable to an investment of no more than \$250,000 made in connection with the organization of the RIC will not prevent the RIC from qualifying for this exemption. See section 4982(f).

When and Where To File

File Form 8613 by March 15 following the calendar year in which the tax liability applies. File it with the Internal Revenue Service Center where the fund's income tax return will be filed.

If more time is needed, use **Form 2758**, Application for Extension of Time To File Certain Excise, Income, Information, and Other Returns, to request an extension of time to file Form 8613. However, Form 2758 does not extend the time for payment of tax.

Rounding Off to Whole Dollars

The fund may show amounts on the return as whole dollars. To do so, drop any amount less than 50 cents and increase any amount from 50 cents through 99 cents to the next higher dollar.

Interest and Penalties

Interest.—Interest is charged on taxes not paid by the due date even if an extension of time to file is granted. Interest is also charged on penalties imposed for failure to file, negligence, fraud, gross valuation overstatements, and substantial understatements of tax from the due date (including extensions) to the date of payment. The interest charge is figured at a rate determined under section 6621.

Late filing of return.—A fund that does not file its tax return by the due date, including extensions, may have to pay a penalty of 5% of the unpaid tax for each month or part of a month the return is late, up to a maximum of 25% of the unpaid tax. The minimum penalty for a return that is more than 60 days late is the smaller of the tax due or \$100. The penalty will not be imposed if the fund can show that the failure to file on time was due to reasonable cause. Funds that file late must attach a statement explaining the reasonable cause.

Late payment of tax.—A fund that does not pay the tax when due may have to pay a penalty of ½ of 1% of the unpaid tax for each month or part of a month the tax is not paid, up to a maximum of 25% of the unpaid tax. This penalty may also apply to any additional tax not paid within 10 days of the date of the notice and demand for payment. The penalty will not be imposed if the fund can show that the failure to pay on time was due to reasonable cause.

Other penalties.—Other penalties can be imposed for negligence, substantial understatement of tax, and fraud. See sections 6662 and 6663.

Signature

Form 8613 must be signed and dated by the president, vice president, treasurer, assistant treasurer, chief accounting officer, or by any other officer (such as tax officer) authorized to sign. Receivers, trustees, or assignees must also sign and date any return filed on behalf of a fund.

Note: If this return is being filed for a series fund (see section 851(h)(2)), the return may be signed by any officer authorized to sign for the RIC in which the fund is a series.

Amended Return

To amend a previously filed Form 8613, file a corrected Form 8613 and write "Amended" at the top of the form.

Specific Instructions

Period covered.—Fill in the space at the top of the form to show the calendar year for which the return is filed. Figure income on a calendar year basis even though the fund files its income tax return and keeps its books and records on a fiscal year basis.

Address.—Include the suite, room, or other unit number after the street address. If the Post Office does not deliver mail to the street address and the fund has a P.O. box, show the box number instead of the street address.

Election under section 4982(e)(4).—This election is available to funds whose tax years end in November or December. If the fund qualifies, it may substitute its tax year for the 1-year period ending on October 31.

If the RIC makes the election, Form 8613 must be filed even if no tax is due. The election must be made no later than the time for filing Form 8613 (including extensions) for the year in which the election will apply. Once made, the election is revocable only with IRS consent.

Line 1a.—Any foreign currency gain or loss attributable to a section 988 transaction that would be properly taken into account for the part of the calendar year after October 31 is taken into account in the following year. For an election under section 4982(e)(4), the last day of the fund's tax year is substituted for October 31.

Also include on line 1a the following items of income.

- **1.** Adjustments that result in the distribution of deficiency dividends under section 860(f) for the year in which the dividends are paid.
- 2. The fund's share of partnership ordinary income (loss), and deductions taken into account at the same time as they are taken into account by the partnership, regardless of the fund's tax year or the tax year of the partnership in which the fund is a partner. See Rev. Rul. 94-40 and Rev. Proc. 94-71.

Line 2a.—Include on this line capital gain net income (CGNI) from deficiency dividends referred to in line 1a above. Also include the fund's share of CGNI as it is taken into account by the partnership, regardless of the fund's tax year or the tax year of the partnership in which the fund is a partner. See Rev. Rul. 94-40 and Rev. Proc. 94-71.

If the RIC does not make the section 4982(e)(4) election, figure CGNI on the basis of a 1-year period ending on October 31 of the calendar year.

If the RIC makes the election under section 4982(e)(4), substitute the fund's tax year for the 1-year period ending on October 31. A special rule applies, however, to the first year the fund makes the election if that year is not the first year the fund is subject to the tax under section 4982. For that year, CGNI is figured for the period beginning on November 1 of the year immediately preceding the election year and ending on the last day of the first tax year for which the election was made.

Line 5.—Enter dividends paid during the calendar year. Include dividends declared in October, November, or December of that calendar year that are payable to shareholders of record on a specified date in one of these months, but only if actually paid by the fund during January of the following calendar year. See section 852(b)(7). Do not include any other dividends paid after the close of the calendar year on line 5.

Line 6.—Line 6 is the total of the following amounts figured for the tax year of the fund ending in or with the calendar year for which this return is filed.

- 1. Taxable income from Form 1120-RIC, Part I, line 26, and the amount subject to tax on Form 1120-RIC, Part II, line 3; and
- 2. Undistributed capital gains designated under section 852(b)(3)(D) from Form 2438, line 11.

Line 12.—Full payment of the tax due on line 12 must accompany this return. Make the RIC's check or money order payable to the "Internal Revenue Service."
